PRESCRIPTION OF DISTRICT FEE RATES ACT, B.E. 2503 (1960)

In the Name of His Majesty King Bhumibol Adulyadej
Sangwan

The Regent

Dated 6th Day of September B.E. 2503 (1960); Being the 15th Year of the Present Reign

Whereas it is expedient to amend the district fee rates;

Be it, therefore, enacted by the King, by and with the advice and consent of the Constituent Assembly serving as the National Assembly, as follows.

- **Section 1.** This act is called the "Prescription of District Fee Rates Act, B.E. 2503 (1960)".
- **Section 2.** This Act shall come into force as from the day following the date of its publication in the Government Gazette.
 - Section 3. The Prescription of District Fee Rates Act, B.E. 2479 (1936) shall be repealed.
- **Section 4.** The district fees shall be collected at the rates prescribed by the Ministerial Regulations, with the exception of the fees that are specifically prescribed by other laws.

Duplication and certification of house registration or official documents for academic enrollment or conscription for military service shall be exempted from fees.

Section 5. The Minister of Interior shall be responsible for the implementation of this Act and is empowered to issue Ministerial Regulations prescribing fees not exceeding the rates in the list annexed hereto and issue regulations for the purpose of implementing this Act.

A Ministerial Regulation shall come into force upon publication in the Government Gazette.
